

MOHAWK IDEALS, VICTORIAN VALUES ORONHYATEKHA M.D.

CURRICULUM PLAN:

The following lesson plans were created to assist educators lead their grade seven and eight students through this website exhibit based on the life and times of Dr. Oronhyatekha (1841- 1907). Approximately four to six week will be required to complete these lesson plans and this time frame will vary according to educators schedules and the amount of time students are allowed to conduct in-class research activities.

GOALS:

- 1) To provide an overview of Dr. Oronhyatekha's life.
- 2) To explore how the evolving Canadian society and First Nations people interacted with each other in the 1800 - 1900's.
- 3) To examine and discuss Dr. Oronhyatekha's Historical Collection.
- 4) To gain an understanding of the values, beliefs and lessons learned from Dr. Oronhyatekha's life.

OBJECTIVES:

- 1) To provide four lesson plans that utilizes the *Mohawk Ideals, Victorian Values Oronhyatekha M.D.* website.
- 2) To explain how each of the lesson plans connects with the specific website section.
- 3) To ensure students use a variety of academic skills to learn about Dr. Oronhyatekha's life and First Nations interaction with Non- Native society from 1800's - 1900's.
- 4) To ensure Educators have access to relevant resources such as the bibliography and additional website links.

STRATEGIES:

These four lesson plans have been developed with the purpose of getting students to explore and learn about Dr. Oronhyatekha's life through this website. While the Grade seven and eight Ontario Social Sciences Curriculum expectations have been taken into account in the actual development of these lesson plans, it should be noted that these lesson plans can also fit into any history curriculum that explores First Nations (in particular Iroquoian), First Nations biographies and the development of Canada in the 1800's -1900's.

The students will be using a variety of academic skills including researching, reading, writing, speaking, analyzing, discussing, preparing and presenting both individual and group written and oral reports.

The lesson plans were also created with the expectation that educators would have approximately two to four weeks to get through this material. Each lesson plan has an approximate time frame for introducing the lesson and expectations and an approximate time frame for the completion of the various activities.

Educators will need to review the website to obtain a good understanding of the layout in addition to reviewing each lesson plan to see how it relates back to the website information/sections. The following is a snap shot of how each website section corresponds to each lesson plan, the required prep work and the assigned student activities. The entire curriculum unit will take approximately four to six weeks to complete depending on the individual educator's class schedule. The estimated lesson plan timeframes have been set out as follows: Lesson one – five class periods; Lesson Two – five to six class periods; Lesson Three – eight class periods; and Lesson Four – one to two class periods.
